

## Release and Waiver of Liability

This Release and Waiver of Liability (the "Release") executed on this \_\_\_\_\_ day of \_\_\_\_\_, 201\_\_\_\_, by \_\_\_\_\_ in favor of Dillon Valley East Condominium Association (DVE), a nonprofit corporation organized and existing under the laws of the State of Colorado. The volunteer desires to work for DVE and engage in the activities related to being a volunteer for a work project. I, the volunteer hereby freely and voluntarily, without duress, execute this Release under the following terms:

1. **Waiver and Release.** I, the volunteer release and forever discharge and hold harmless DVE and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my volunteer work at DVE. I, the volunteer understand and acknowledge that this Release discharges DVE from any liability or claim that volunteer and minor may have against DVE with respect to bodily injury, personal injury, illness, death, or property damage that may result from participation in the DVE work. It is also understood that DVE does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury, illness, death or property damage.
2. **Insurance.** I, the volunteer understand that I expressly waive any such claim for compensation or liability on the part of DVE beyond what may be offered freely by the representative of DVE in the event of such injury or medical expense.
3. **Medical Treatment.** I, the volunteer, hereby release and forever discharge DVE from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during the minor's time with DVE.
4. **Assumption of Risk.** I, the volunteer, understand that the time with DVE may include activities that may be hazardous to me including, but not limited to, construction activities, loading and unloading of heavy equipment and materials, and local transportation to and from work sites. Also I, the volunteer recognize and understand that the time with DVE may, in some situations, involve inherently dangerous activities. As the volunteer, I hereby expressly assume the risk of injury or harm in these activities and release DVE from all liability for injury, illness, and death or property damage resulting from the activities of a minor's time at DVE.
5. **Photographic Release.** As the volunteer, I grant and convey unto DVE all right, title, and interest in any and all photographic images and video or audio recordings made by DVE during the work with DVE.
6. **Other.** As the volunteer I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Colorado in the United States of America, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Colorado. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release, which shall continue to be enforceable. This waiver is applicable 1 year from date of signature.
